The change is as follows: SECOND-READING RULE (ECM 7/18/19) 1. FOR SECOND READING ITEMS, ONLY MOTIONS TO MODIFY OR DELETE PART/S OF THE POLICY ON THE FLOOR AND VOTING ON THE MAIN DOCUMENT WILL BE CONSIDERED. 2. DURING A SECOND READING ITEM THE SENATE MAY GO INTO A CLOSED-DOOR SESSION FOR ITEMS THAT ARE SENSITIVE AND WARRANTS DELIBERATION. A CLOSED-DOOR SESSION MAY BE INITIATED BY THE SENATE CHAIR OR BY A MAJORITY VOTE OF THE SENATE. This action will stand approved at the close of business today unless there is a request to agendize it. 1.1.4 Beginning Fall 2019, CETL is offering "Reading and Writing in the Disciplines: New Certificate Program." These series of six workshops introduce you to best reading and writing practices, and provide tips for lightening the grading load. It will be facilitated by CETL Faculty Fellow Dr. Margaret Finnegan, who helped develop the program.
