- 1.5 AVP and Dean of UG Studies Michelle Hawley announced: With generous financial support from the Teagle Foundation, the College Futures Foundation, and the CSU Chancellor's Office, six California State University campuses are concurrently implementing an initiative to review and redesign undergraduate majors for greater student success. This initiative will provide grants to fifteen programs at each of the campuses, between January 2020 and December 2021. The six participating campuses are Chico, San Francisco, and Sonoma in northern California, and Los Angeles, Pomona, and San Diego in southern California. Your undergraduate degree program is invited to be a part of this pivotal initiative.

The Office of Undergraduate Studies is issuing this Call for Proposals for grants of up to \$8,500 that enable undergraduate degree-granting programs to undertake curriculum reforms in their majors that structure student learning and academic progress in coherent and intentional ways that lead to increased student success, retention, and graduation.

Five grants will be awarded in November 2019 (for projects beginning in January 2020), and ten more will be awarded in the 2020-2021 academic year: five awarded in May 2020 for projects beginning in August 2020, and five awarded in December 2020, for projects beginning in January 2021.

CONCERNS FROM THE FLOOR

2.1. Chair Prabhu reported responses from Michelle Hawley, Tom Enders, Cat Haras, Beverly Bondad-Brown, Nancy Wada-McKee and Office for Students with Disabilities (OSD) to the concerns raised by Senator Ellis on September 24, 2019 : Concern: Would it be possible to provide departments with a group email that includes majors and pre-majors to facilitate email communications between faculty, staff and students? Response: Departments can use EAB to identify and communicate with their majors and pre-majors. Department Chairs and faculty advisors who would like to know more about how to use EAB are encouraged to speak with the Director of Student Success in their College Advising Centers.

Concern: What resources are available on campus to support instructors in providing/preparing accessible instructional materials? **Response:** CETL can provide information with faculty about how to ensure that their course materials are accessible. See http://www.calstatela.edu/cetl/edtech/accessible-instructional-materials.

Concern: Also, would it be possible for the Office of Student Disabilities to send out the accommodations contract when students enroll in a course? **Response:** Yes, if the student makes their accommodation request/selection through their OSD online account (AIM) after they enroll in a course, OSD will send the notification (that contains accommodation information and the alternative testing contract) to faculty. OSD proactively reaches out to select student groups (blind and DHH students) to remind them to make their requests as soon as they enroll. http://www.calstatela.edu/osd/faculty

2.2 Chair Prabhu reported a response from Barbara Queen to the concern raised by visitor, Jillian Tromp, on September 24, 2019:

Concern: My name is Jillian Tromp and I work in the Department of Physics and Astronomy. I would like to raise a concern that some Evacuation Maps recently posted in the Biological Sciences building are in the wrong location. It is surprising that a tool like an evacuation map intended to help people is posted in an incorrect location and could potentially cause additional harm to students, faculty, and staff during an actual emergency. I submitted a Safety/Hazard Report on the RM/EHS website last week but I have not received any follow up and the incorrect evacuation maps are still posted. I think correcting this should be a priority and that is why I'm raising this concern at the Senate meeting today. **Response:** The locations for the evacuation maps have all been reviewed and approved by the State Fire Marshal. Unfortunately, we had an error in the insert where two locations were very close and the maps were accidentally swapped. We have corrected this and appreciate Jillian bringing this to our attention. Please let me know if you have additional questions. Thank you.

2.3 Senator Flores raised the following concern: I'm raising a concern in regards to the Ad-Hoc Advisory Search Committee for the Provost and Vice-President of Academic Affairs. With all due respect to the newly-elected committee members, I want to make certain that the search committee reflects the diversity of our campus and that any additional members appointed represent the varied voices of our university community. This is not to state that the senators already chosen for the committee will not serve the interests of all members of our university community; I just believe that all of our voices should be an integral part of the process.

Chair Prabhu responded from the floor that President Covino will be adding additional faculty to the committee and is keeping in mind the need for diversity when making his selection.

2.4 Senator Amaya raised the following concern: Most recently, it has been brought to our attention that the some of the Braille writing system in King Hall had been vandalized, making it harder for students who identify with visual impairments. A university wide email was sent out, stating that the issue was identified and it was being resolved during that time the email was sent. I wanted to follow up, and see if the Braille writing system that had been vandalized had been replaced. It was a concern of mine since this issue has an immediate effect on our students who identify with a visual impairment. Thank you.

Please see the response below from Cal State LA's University Counsel regarding your Intent to Raise question memo:

"The Chancellor's Office is continuing to negotiate a systemwide IP policy. The 2014 policy signed by the President needed to be approved through the meet-and-confer process with the unions on campus before becoming actual policy. We received word in early 2015 to stop that process because there would be systemwide bargaining on a systemwide policy starting that year.

The IP policy set forth in the Unit 3 Collective Bargaining Agreement (which has been extended by contract to June 30, 2020), Article 39, remains in effect. The campus Patent Policy, set forth in Chapter 8 of the Faculty Handbook, covering all employees, including faculty, has been in effect since 1998, and remains in effect."
