- 2.1 Senator Fernando raised the following concern: I want to take this opportunity to voice my disappointment at the Senate Exec's current delay or failure to get back to the larger Senate body regarding the idea of CSULA coming together to create a curriculum and/or activities around the 1619 project. During the Senate 101 meeting we were informed that "concerns from the floor" was the opportunity for anyone to voice any kind of concern or opinion to the Senate. This was to be an informal airing of opinions and concerns. Early on during the semester I had asked whether I could suggest on the Senate floor that as a body we come together to discuss the issue of the enslavement of peoples and an acknowledgement that much of our privilege comes from not standing on the shoulders of giants, but rather trampling on the faces of enslaved people. I was first informed by the Senate Chair that she would let me know about this issue, then she promised to take it up with Senate Exec, but it has been weeks now and I have heard nothing back. Is there still time to discuss such an engagement as a community, or has this opportunity passed us by, since the year is slowly moving towards the end?

2.2 Senator Loot raised the following concern: On Thursday, October 10, four students were stuck in the new and only working elevator in the library. I was working at the Office of Graduate Studies when one student came up to me to inform me that there were students inside the elevator and cannot get out. I checked on them and told them to calm down because I am going to ask for help. I called the Library front desk twice, nobody answered, so I called Matthew Prutzman. Somebody came down to let them out probably 10-15 minutes after I called them. There were incidents that graduate students would tell me that the elevator is acting weird it and felt like it was going to drop anytime. One time I experienced that too, the elevator door closed immediately and my backpack almost got stuck when it closed. I don't use the elevator anymore because of the fear of getting stuck in there. There are 3 elevators in Library North. Two were shut down for maintenance or repair. Those elevators have not been operational since the semester started. Hope someone gives attention to this because this is a burden especially for our ADA students. This can also be traumatic for students. Thank you.

2.3 Senator Hanan raised the following concern: I have a question about the ability to exempt courses from on-grid scheduling that departments need to schedule after the deadline for scheduling courses has passed. The concern being that the university appears to have a current interest in enforcing on-grid scheduling, which (for example) splits a 1 hour 40 min lecture or activity into two 50 min. sessions. This is pedagogically unsound in many cases, and particularly untenable for lecture and lab courses involving film/TV analysis, production, and performance courses. I understand that the goal is to make scheduling more efficient, but is there a workaround to what currently threatens course content and activities?
