	13.2	 Senator Esparza announced his intent to raise the following question: On the Senate meeting of 2 Feb 2021, I moved to table a motion that would punish faculty for not providing feedback to students within a specified timeframe. In so doing I also speculated on the committee's motives. In direct response to my comments, the Senate Chair specifically accused me of being uncivil on the floor of the Senate and did not allow me to respond to this baseless and vile accusation. In 2019, the Senate passed my resolution, "Resolution affirming the principles of the Universal Declaration of Human Rights" (attached). Article 19 of the Universal Declaration of Human Rights reads: Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers. While the Senate Chair may disapprove of my motion to table or of my speculation, I have every right to express my opinion thereof. To that end my question to the Senate Chair is: what justification do you have to publicly accuse me, a voting member of the Senate Chair is: what justification do you have to publicly accuse me, a voting member of the Senate, of incivility during my motion to table?
