CONCERNS FROM THE FLOOR

- 2.2 Senator Krug raised the following concern: I would like to follow up to a concern I raised last week regarding faculty not being able to follow the procedure for bringing undergraduate and first-year graduate students back to campus because we had not been given an assessment of the capacity of our research and creative spaces. The Senate was advised that the information was provided; it's been clarified to a degree that this had not been done. EHS was to provide this information yesterday but was wondering if this information has gone out?

- 3. Chair Bettcher provided the following response from Karin Brown, Associate Vice President and INTENT TO RAISE Dean of Graduate Studies to Senator Krug's intent to raise question from the meeting of April 13, QUESTIONS 2021 (ASM 20-18):

The University will waive fees for graduate students completing theses or projects over the summer due to delays caused by COVID and prolonged campus closure (\$350 for UNIV 9000 + \$25 to change their graduation term), if approved by their faculty thesis/project instructors. The Office of Graduate Studies handles requests for students to complete their thesis/project over the summer on a case-by-case basis because we cannot compel faculty to work with their graduate students during their off-term. Before requests are approved, the Dean of Graduate Studies asks faculty research mentors to confirm in writing that they are willing and available to work with graduate students during the summer term. The Dean confirms that the graduate student has previously enrolled in 5990: Thesis Research or 5995: Project with their thesis instructor and has a RP on their record. Then the Dean of Graduate Studies approves enrollment in UNIV 9000 (0 units) for the summer term. This procedure has been followed prior to the pandemic and last summer when extensions were provided based on individual faculty approval. Again, the University will waive fees for graduate students enrolling in UNIV 9000 after approval by their faculty research mentor.
