Chair Bettcher began with a Tongva land acknowledgement and reviewed protocols and reminders about participating in Senate meetings and iClicker cloud use.

1. 1.1 Chair Bettcher announced: President Covino approved the following recommendations: ANNOUNCEMENTS Recommendation for optional "Peer Observations of Instruction for the 2021/22AY" New Policy: Faculty Teaching and Supervision Records, Faculty Handbook, Chapter VI effective immediately

Policy Modification: Personnel Accomplishments Report (PAR), Faculty Handbook, Chapter VI – effective immediately

Policy Modification: Preferred Name Policy, Faculty Handbook, Chapter V – effective immediately

The Faculty Handbook and Senate website has been updated to reflect these changes.

- 1.2 Senator Talcott announced: Good afternoon, colleagues. Happy Election Day! I hope you will all vote and encourage your students to do so as well. My addendum is that due to the legislature and Gov. Newsom, the CSU was given what even Chancellor Castro calls a "historic budget." At the bargaining table, CFA and CSU management are increasingly far apart on things, including salary. IF we go to impasse, IF we then get through mediation, and IF we then go to fact-finding by a neutral party, because of this historic budget made possible by the governor, it will be difficult for the CSU to credibly claim that they don't have the resources to pay us what we deserve, much less to pay us enough to keep up with inflation. Another addendum is that Gov. Newsom was courageous as Lt. Governor a few years ago. As a member of the CSU Board of Trustees. he boldly and publicly challenged his fellow trustees (something that doesn't often happen on that Board) to oppose the proposed student fee hikes a few years back. Because of his actions that day, the student fee increase failed. Please consider these points, and Happy Voting Day!

I think there is a need for more clarity in gathering information so that students and faculty are protecting their health.

However there remain areas where employees may interact with the public that do not have plexiglass installed yet. Can you provide a list of ALL areas (please include temporary and permanent areas) where employees interact with the public and do not currently have plexiglass installed, and provide a timeline for when the plexiglass will be installed in those areas?
