- 1. 1.1 Chair's announcements:
  - 1.1.1 I would like to introduce Omar Iniguez, who is our new staff member in the Academic Senate Office. Please help us in welcoming him to our office.
  - 1.1.2 Please mark your calendar for an additional Senate meeting on Tuesday, May 2.
  - 1.1.3 Our next Senate meeting in two weeks will include a discussion about Faculty Perceptions of Administrators. Elliott-Brown, AVP and Dean of Graduate Studies, announced: I just want to thank my faculty colleagues for responding to my request at the last meeting for the Sally Casanova applicants.
