 - For lecturers who has teaching appointments in two colleges, which college is responsible for submitting range elevation?
 - Diversity of class offerings and meeting times

9. 9.1 It was m/s/ (Riggio) to insert the following in line 13:

WHEREAS: The Academic Senate of Cal State LA is nevertheless concerned that AB 928 compels CSU faculty to make a major curricular decision based on legislative priorities and the threat of administrative intervention instead of its own faculty expertise in developing and delivering university curricula to its students; and

WHEREAS: The Academic Senate of Cal State LA reaffirms the role of CSU faculty in developing and delivering its own lower- and upper-division General Education programs to our students, based on the existing CSU GE Breadth requirements; and

and insert in line 19:

RESOLVED: That the Academic Senate of Cal State LA reaffirms that it is the role of college and university faculty, not legislators or administrators, to develop and deliver university curricula for students; and be it further

RESOLVED: That the Academic Senate of Cal State LA reaffirms the role of CSU faculty in developing and delivering its own lower- and upper-division General Education programs to our students; and be it further

RESOLVED: That the Academic Senate of Cal State LA reaffirms that it supports maintaining the existing CSU GE Breadth requirements for first-year students entering Cal State LA: and be it further

- 9.2 Debate ensued and the Riggio motion was APPROVED. (V:38/4/3)
- 9.3 The resolution was APPROVED. (V:39/1/7)
- 9.4 It was m/s/ (Flint) to forward the resolution to the ASCSU ahead of the approval of the minutes. No objections were raised.
- 10. 10.1 Chair Bezdecny advised the body of where debate ended from the last meeting.
 - 10.2 Debate ensued.
