Personal commentary:

I continue working as a sculptor. The majority of my pieces are carved from American Lime Wood. It's the favorite wood for sculptors and carvers. Masters of wood carving found it ideal for delicate sculptures. My work has been strongly influenced by the work of the Native People of the Northwest Coast, their totems and symbols utilized in the work of the Native Americans. I am also interested in the Animals of the Southwest, they have fascinated me and have become the subject of my work. When I determine how I am going to work with the subject matter, I continue to carve the wood until each piece begins to mature.

I enjoy adding to many of the surfaces symbols found in Native American Art. Many of the animals once important to their survival are depicted in the symbols. These symbols are added

after the carving is completed and before the final sealer coat is applied.
