OFFICERS NOMINATED TO LEAD ASSOCIATION DURING 1982-83 YEAR

A slate of officers to lead the Emeriti Association for the new year beginning July 1, 1982, has been approved by the Executive Committee for submission to the membership at the annual meeting on Tuesday, April 13.

The nominees were proposed by Robert Forbes, chairman of the Nominating Committee, and were as follows:

DONALD MORTENSEN for Vice President - President Elect. He has served for the past two years as a Member-at-Large of the Executive Committee.

GEORGE MANN for Secretary. He has served by appointment for the latter part of the year as a replacement for Keith Gummere.

EDWARD NELSON and **JANE MATSON** for 2-year terms as Members-at-Large of the Executive Committee.

Nelson, who retired the past year as Professor of Finance in the School of Business and Economics, will be new to the Executive Committee. Matson served the past year as a replacement for Al Tuohino when he was elected Treasurer.

MICHAEL GRISAFE, Vice President—President Elect the past year, succeeds automatically to the Presidency.

SIDNEY ALBERT and **LESLIE CROMWELL** will be serving the second year of their 2-year terms as Members-at-Large of the Executive Committee, and **ALVIN TUOHINO** will be serving his second year as Treasurer.

ALICE THOMPSON will continue on the Executive Committee as Immediate Past President.

SESSION SCHEDULED AS LUNCHEON AFFAIR IN UNIVERSITY UNION

Association and Senate Committees engage In Productive Session

The Executive Committee of the Emeriti Association had a most successful session of an hour and a half with the Executive Committee of the Academic Senate on February 17.

Among the wide range of topics discussed were assistance of emeriti in counseling students in the new Advice Center, involvement of emeriti in the pre-retirement sessions conducted by the Personnel Office for faculty, eligibility of emeriti representation on University committees.

There was also discussion of the need for further clarification of the policy involving granting of emeriti status, and the Association was invited to submit ideas and recommendations.

The Senate Committee endorsed with enthusiasm the proposal for an annual Emeriti Day on campus. It was agreed that the celebration should begin with the fifth anniversary of the founding of the Emeriti Association on February 9, 1983.

The two bodies agreed that another joint session should be held during the Fall Quarter of 1982.
