New Officers Chosen To Lead Association For the Coming Year

A new team of officers to lead the Emeriti Association for the coming year was elected at the annual meeting in April and took office on July 1.

Alice Thompson, Vice President and President Elect for 1980-81, is the new President of the Association.

Dr. Thompson, a member of the faculty for 27 years, retired as a full professor in June, 1979. Her last service was as Chair of the Department of Psychology.

Dr. Thompson devoted her entire life to education, as a high school teacher of English and as a college professor in the fields of psychology and special education, with special emphasis on the behavorial disorders and learning disabilities of children. She was the founder and first director of the Learning and Behavior Problems Project of the Cal State L.A. Associated Clinics.

Dr. Thompson is continuing her lifelong activity as a lecturer and consultant in the area of children's educational and behavior problems, and continues to head Escalon, a Pasadena school for children with such problems.

Michael Grisafe, Treasurer since 1978, was elevated to Vice President and President Elect.

Elected to a 2-year term as Treasurer was Alvin Tuohino, who had been serving as a Member-at-Large of the Executive Committee.

The new Secretary for the coming year is Keith Gummere, and serving as the Association's new Senator is Richard Lilliard.

Re-elected to the Executive Committee as Member-at-Large were Sidney Albert and Leslie Cromwell, both for two-year terms. Elected to complete the term of Al Tuohino on the Executive Committee was Jane Matson. Continuing on the Executive Committee is Donald Mortensen.

New Attention Focused Upon the Role Of Emeritus Faculty in CSUC System

New attention has been focused upon the role of the emeritus faculty on the 19 campuses in the California State University and College system, as the result of actions taken recently by the Statewide Academic Senate.

Providing leadership in gaining this recognition for retired faculty has been Sidney Albert, prime mover in organization of the Cal State L.A. Emeriti Association. Supporting his efforts has been Robert Kully, member of the Cal State L.A. faculty now beginning has unprecedented third year as Chair the CSUC'S Statewide Academic Senate.

Two important resolutions, one urging recognition for emeritus faculty on the individual CSUC campuses and the other creating an ad hoc committee to study the role of emeritus faculty, were adopted unanimously by the Statewide Academic Senate in May.

The text of these resolutions is reproduced below.

Appointment by CSUC Senate Chair Kully to serve on the Ad Hoc Committee to Study the Role of Emeritus Faculty in the CSUC are Donald Moore, member of the Cal State L.A. faculty who will chair the committee; Howard Kimall, an emeriti faculty member at Cal State, Long Beach, and Mitchell Marcus, an emeriti faculty member at Cal State, Northridge. Sidney Albert has been invited to serve as a resource person for the committee.

RESOLUTIONS ON EMERITUS FACULTY ADOPTED BY ACADEMIC SENATE, CSUC

EMERITUS FACULTY STATUS

WHEREAS, emeritus faculty have given long and effective service to their respective campuses and The California State University and Colleges and should be permitted and encouraged to continue as productive and honored members of the academic community; and

WHEREAS, continued close relationships between emeritus faculty and the academic community are highly beneficial to both; and

WHEREAS, budgetary items and augmentations are difficult and at times impossible to secure for necessary and desirable functions of regularly employed faculty; therefore be it

RESOLVED: That the Academic Senate of The California State University and Colleges urge each campus to accord emeritus faculty privileges, and, where they desire, responsibilities appropriate to their continued status as productive and honored members of the academic community; and be it further

RESOLVED: That, where practical, budgetary items and augmentations should be advanced on behalf of emeritus faculty; and be it further

RESOLVED: That the Academic Senate CSUC urge each

campus to offer to emeritus faculty all practical and useful privileges, responsibilties, benefits and courtesies, within the general bounds of existing budgets and the prior teaching and scholarly needs of regularly employed faculty including, but not necessarily limited to the following:

- (a) full library privileges,
- (b) laboratory access and use, provided that proper insurance is available,
- (c) office space,
- (d) opportunity for grants,
- (e) attendance at faculty meetings as ex-officio, non-voting members with floor privileges,
- (f) eligibility for appointment and/or election to faculty committees,
- (g) option of lifetime subscriptions to all campus news publications and the like which go to regularly employed faculty,
- (h) parking privileges, and
- (i) use of recreational and social facilities and invitations to university functions, with the same access and ticket arrangements as are available to regularly employed faculty.

STATEMENT ON EMERITUS FACULTY

RESOLVED: That the Academic Senate of The California State University and Colleges reaffirm its resolution "Emeritus Faculty Status" (AS-980--78/FA, March 2-3, 1978); and be it further

RESOLVED: That the attached AAUP Statement on Emeritus Faculty be endorsed in concept by the Academic Senate CSUC; and be it further

RESOLVED: That an ad hoc committee including emeritus

faculty representation be established to study the role of emeritus faculty and make recommendations to the Academic Senate CSUC; and be it further

RESOLVED: That the Chair of the Academic Senate CSUC be directed to forward the AAUP Statement and the Sidney P. Albert Statement "Proposal on Retirement Issues" to the respective CSUC senates/councils with a request that they each consider recommending implementation of those portions of the document having local applicability.

Report of the Ad Hoc Committee On Status Of Emeriti Professors

Do emeriti faculty stand under the collegial umbrella or are they outsiders? Is there a two-way caring relationship between the University and the retired faculty? The answers to these and related questions are yes, no, and perhaps.

To the question of the status of emeriti professors in academic governance and in the academic programs of the University, the following answer was indicated: emeriti professors may not serve on any standing committees, including sub-committees and personnel committees. Recommended, and still subject to approval of the Academic Senate Executive Committee, is an enabling interpretation permitting appointment of an emeritus professor to a special committee or an ad hoc committee where benefit to the University is the primary justification.

An interesting question was raised when some of the emeriti faculty who occasionally teach classes were invited to join part-time and temporary faculty in collective bargaining actions.

Questions of use of laboratories, data processing equipment and duplicating equipment in research-related programs by emiriti professors have not been resolved.

The collegial umbrella was spread first by Louis Eggers, Academic Senate chair, and confirmed by Frieda Stahl, recently elected chair, by an agreement to hold annual meetings between the executive committees of Emeriti Association and the Academic Senate.

President Rosser, in a similar gesture of good will wishes to hold semiannual meetings with the Emeriti Association Executive Committee.

No report would be complette without expressing great appreciation to the department and school administrators who have maintained caring communication with their retired professors, and to the many emiriti who are doing volunteer work for the University.

Ed. Note: Don Mortensen represents the Emeriti Association on the committee. Named last spring by Academic Senate Chair Louis Eggers were Eleanore Tweedie, representing the Academic Vice President, and Jane Lewis, representing the Faculty Affairs Committee.
