## 7. Creation of Schools with the College of HHS, EPC 00-14

S. Cash provided background on this item. The requests from Social Work and Nursing were reviewed and the following action taken:

M/s/p to challenge the proposals, and to recommend that no proposals to change a department to a school be considered until establishment of University criteria.

Rationale: There are no criteria for evaluating proposals from departments for change to schools in current University policy. EPC believes that in the absence of stated criteria there is no systematic way to evaluate such requests, and that a review of such proposals on an ad hoc basis could have serious impact on the credibility of the University's programs. It also appears that the change from department to school is significant, and more than just a change in title. Therefore, EPC does not support the proposal from the College of Health and Human Services at this time, and recommends the creation of University criteria for such requests that can be applied to any subsequent proposals.
