Program Modifications

MA Special Education: Inclusion Facilitator Option

Program changes move EDSP 400 from the core to a prerequisite to the program. EDSP 409 and EDSP 413 are being deleted. EDSP 508 and EDSP 555 move from required courses to elective courses.

MA Special Education: Transition Studies Option
