ACTIONS REPORTED BY THE EXECUTIVE SECRETARY

Program Modifications

BS in Criminal Justice

- Removal of CRIM 301 from the narrative for Criteria for Admission to the Major.
- Change Requirements for the Major narrative to clarify students receiving two grades below a C in core courses must change their majors.

MS in Kinesiology

- Change the title from Adapted Physical Education Specialist Credential to Adapted Physical Education Authorization APEAA.
- Reduce the number of credits for the APEAA from 36-credits to 28-credits:
 - KIN 491 (4) removed from undergraduate curriculum (Approved by undergraduate curriculum committee 1/17/2013).
 - Remove EDCI 535 (4) course from the APEAA program requirements.
- Change graduate course KIN 536 to an undergraduate course, KIN 434, to allow the content, with the exclusion of the advanced techniques, to be included in the undergraduate requirements.
