M. Soldatenko reported the following items being discussed at the Executive Committee meeting:

6. Time-Certain: T. Allison, Dean of Arts and Letters - Fiscal Issues at CSULA

The Committee members shared with Dr. Allison their concerns regarding departmental restructuring in the College of Arts & Letters. Dr. Allison explained to the Committee the split of the Communication Studies Department (*Budget Item 7.4*) was initiated by Faculty members after seeing the fast growing demand for the TV and Film program. Dr. Allison discussed the acquisition of the LDS Church Building by University Auxiliary Services (UAS) and consequent leasing it back to the University. This project will benefit the University, UAS, and the College of Arts and Letters— in particular the Television, Film and Media Studies programs.

The merging of departments to create the Performing Arts Department (*Budget Item 7.3*) is more of an economically driven decision due to current staffing changes such as faculty retirements, lack of administrative support, and department salary funds shortage. It has been estimated that the fiscal benefit of the merger can be estimated at \$100,000 in salary and benefits.

The FiPC members asked for input from Dean Allison on current Academic Affairs and University fiscal matters. Challenges for Academic Affairs under the current budgeting environment were discussed.
