1. Call to Order

Announcements

M. Caldwell announced: There are 3 things that I need to mention. The 1st item is #FreetheARTPdocuments. There were ARTP documents that were submitted in 2012-2013 that were never approved. The departments and Colleges have 3 choices, send the document forward as previously submitted, review the document and add revisions, or disregard the document and continue with the version currently posted on the Faculty Affairs website. The 2nd item is that Chairs, Deans, Assistant Deans and Deans Assistants will have access to the Faculty Affairs calendar with deadlines posted.
