1. Call to Order

H. Riggio called the meeting to order at 1:43 p.m.

M Fryling announced: In my department we have a lot of undergrad programs with one faculty and there is a lot of tension because there is no hiring. My faculty send me job applications from other CSUs. Maybe our campus is unique because there are some programs that are on the verge of losing their credential status.

N. McQueen responded: I talked to the provost and I was told no. I didn't know that was happening in your dept. Send me the information you have and I could try some more.

H. Riggio responded: This is something that could be asked in the senate.

M. McLendon announced: A vaccine was announced. If this is distributed in April, I want the students to go back to the classroom as soon as possible. There should be some talk within senior admin.

There is no peer observation and if we do not have any student opinion surveys, we do not know what is going on in the classroom. I will look to see what other universities are doing.

H. Riggio and N. McQueen responded: No to the first question and Yes to the second question.

H. Riggio asked: Does the 125% rule apply to S-factor at Cal State LA?

N. McQueen responded: I talked about it a little bit. Send it to me and I will try to get back to you. One thing I can say is that the 125% has to be different than regular teaching.
