## **Course Description**

Fungal Pathogenesis course will focus on the host-fungal pathogen interactions that affect the establishment and outcome of human fungal infections. This course will first cover the basic biology of fungi, then specific pathogens, key virulence factors, the pathogenesis of fungal infections, and host responses. Lectures will be based on a review of current primary literature and review articles. Students will be required to present key primary research articles related to the topic. Group activities in the course will provide opportunities for the students to develop critical reading, data interpretation, presentation, and communication skills.

## **Student Learning Outcomes**

This course will emphasize familiarity with fungi in the context of human disease. Students will explore the interactions between pathogenic fungi and human hosts. Students will use current research and scientific literature to understand the establishment and outcome of fungal infection. This course will cover general principles, specific pathogens, key virulence factors, and host responses.

Upon successful completion of this course, students will be able to:

- Understand the medical importance of pathogenic fungi
- Explain the biology and pathogenesis of key fungal pathogens
- Explain strategies fungi use to establish & maintain infection, as well as host defense response.
- Describe treatments for fungal diseases.
- Critically evaluate scientific literature
- Interpret data from scientific research articles
- Compose and present scientific information
- Work cooperatively as a group

#### **Assessments**

**Exams**: 1 midterm and 1 comprehensive final exam.

- Exam format may include multiple choice, short answer, and/or essay questions.
- The final exam covers material for the *entire course*, including special seminars, class discussions, lecture content, research articles, and case studies.

Research paper presentations: The presentation schedule will be made at the first class meeting. Each student select a recently published <u>primary research article</u> that is relevant to the lecture topic for that day. The presentations are 15 min PowerPoint-style. The student will provide the instructor with an electronic copy of the selected article <u>at least one week before</u> the presentation date for approval. The articles will be posted on Moodle for the other students to access. The presentation will be evaluated based on the presenters' presentation skill (critical reading, data interpretation, preparation of slides, engagement of audience and timing) and intercommunication with the audience.

**Post-presentation Group Discussion**: All class members are required to read articles before presentations and to participate in the discussion and assignments. The whole class will have group discussion sessions after each presentation. Participation in lectures and presentations will be considered in determining final grades.

**Assignments**: Assignments may be online or in class. In-class assignments cannot be made up, and attendance is required for credit.

**Extra credit:** There will be no unplanned extra credit.
