



# Bilingual Authorization Program

## Program Overview

The Bilingual Authorization Program is designed for credentialed Los Angeles-based bilingual teachers, who have an interest in adding Bilingual Authorization to their skill set. The program is approved by the California Commission on Teacher Credentialing (CCTC).

This accelerated three-course program qualifies students for authorization in one of the following Cal State LA-approved languages: Spanish, Korean, Mandarin, Cantonese and Tagalog.

Bilingual Authorization courses prepare individuals to teach in two languages covered by their primary credential. Upon completion of the program, students will be prepared to develop and implement bilingual and dual language curriculum strategies, and adapt them to cross-cultural settings.

## Admission Requirements

This program satisfies the education requirement for obtaining a Bilingual Authorization from the California CTC and is open to anyone. However, students must (1) hold a clear, preliminary, or intern credential, and (2) pass the World Languages CSET (Subtest III for Spanish, Korean, Mandarin, and Cantonese; or Subtest II for Filipino) prior to self-recommendation to the California CTC.

## Program Requirements

Students complete 7 units of coursework that include the following course:

- EDCI 5560: Inquiry into Methods of Teaching Academic Literacy in the Target Language (3 units)
- EDCI 5570: Research and Pedagogy for the Bilingual Learner: Exploring Cultural Impact (3 units)
- EDCI 5580: Reflection, Synthesis, and Assessment: Bilingual Authorization Portfolio (1 Unit)

## Program Cost

Cost Per Unit	Total Program Cost

Cost does not include CSET examination fees nor Bilingual Authorization CTC self-recommendation costs/fees.

Complete payment for the courses can be made in two installments (\$855, \$1,140). Installment payments must be completed by January 15, 2020.
