#### 7.1 **Information Dissemination to Students**

ASI is in the process of developing a web site as another way to disseminate information to students; it should be operational by the Winter Quarter. # 7.3 SPC Internal Guidelines for Early Registration

J. Woosley, University Registrar, was a time certain guest. A question and answer period followed. It was agreed by consensus that the University Registrar will request each faculty advisor or director of a student group or program granted early registration to update their student list. If the updated student list of a group or program is not provided, then the early registration privilege for that group or program will be forfeited and a request for early registration will have to be resubmitted to the Student Policy Committee. The University Registrar will notify the Student Policy Committee of any group or program that is in default. The Student Policy Committee will send a notification letter regarding the impending suspension of their early registration status. Summer Quarter will not be penalized.
