- 1. <u>Call to Order</u> The meeting was called to order by G. Washington, Chair, at 1:36 p.m.
- <u>Time Certain L. Fong, Director, Student Financial Aid</u> L. Fong presented on the status of Student Financial Aid and provided the Committee with an overview.

- 7. Liaison Reports
  - 7.1. Executive Committee Liaison

## 9. Privacy for Breast Feeding Students

G. Washington responded to the *Intent to Raise* question raised by C. Uyeki. R. Navarro, Assistant Director Human Resources Management, indicated there is no policy but we should use "reasonable accommodations." J. Tipton, Director of Student Health, stated "no special accommodations are required but certainly common decency would compel one to try to work things out if there was a need"

C. Uyeki, suggested a possible space in the new University Student Union include a lounge for such a situation. A. Ross said he would share this information with the University Student Union's Executive Director.

## 10. Student Lounge for Charter College of Education

A. Ross responded to the *Intent to Raise* question by P. Chen. The University has no passive leisure space while the University Student Union is down. Since space is non-existent at this time, Dolcini's Café may be used to accommodate students.

G. Washington informed the committee on the charge from the Academic Senate to review and develop policy if necessary, to address students' freedom of expression on campus. A. Ross, Vice President for Student Affairs stated that he is currently working with the following individuals:
