A. Ross clarified the scholarship process by describing the relationship between University Development Office, the Financial Aid office and the academic departments. A. Ross recommended he Executive Committee invite the scholarship coordinator and the University Development Assistant Director to gain more knowledge about the scholarship process as well.

It was agreed to have a presentation on the scholarship process at the next meeting.

7.2. Academic Advisement Subcommittee

M. Adamian reported the Academic Advisement Subcommittee continues its discussion on the AAMG Advisement Pilot Proposal through the College of Natural and Social Sciences.

M. Adamian further announced the Intellectual Property Task Force will convene and as liaison to the task force, he will report back to Student Policy Committee.

7.3. <u>Associated Students, Inc.</u>

M. Pomirchy reported ASI continues to discuss the veteran affairs position. There is an ASI proposal on the table for a veteran affairs position within ASI. No decisions have yet been made.
