The proposed dates must then be approved by both the President's office and the Provost's office. This issue came up

during the drill debriefing. Phil LaPolt, Acting Assistant Vice President Academic Affairs -Academic Personnel, explained to those in attendance that there is really no great time for the drill because of all the testing conducted throughout the quarter.

The committee received a charge and discussed the need to establish a guide here at CSULA. The committee agreed that the CARE Team guidelines would be very useful if they were accessible and uploaded to the web. A formal response to the Executive Committee will be drafted.
