The committee would like to look into this data possibly by College. Members raised concerns regarding the negative impact our campus's pre-pay policy may have on students', in particular international students', ability to utilize their early registration status. Members also raised concerns regarding how Foster Youth are being supported, and expressed wanting to learn more about the Foster Youth program and what supports are currently in place. D. Won asked committee to submit further questions and points of discussion. Based on the compiled questions, committee will consider inviting various administrators and program staff, including C. Cobb, University Registrar, to a future meeting to help lead the discussion.

## 12.1 Priority Registration Request

The committee reviewed the request for priority registration submitted by the Office for Students with Disabilities (OSD) for service providers (Notetakers). It was M/S/P to approve the OSD service providers to move from early registration to priority registration.
