K. Baaske shared his report via email. At its last meeting, Tuesday, 10/20, it was announced that the Academic Senate will not meet on Tuesday, November 3, because it is election day.

The Senate did NOT have time to fully consider a resolution in opposition to the Chancellor's draft Executive Order implementing the new Ethnic Studies graduation requirement. I believe that 13 other CSU campuses have passed such a resolution. Nor

The Senate spent a good deal of time with the Provost. He answered a multitude of questions. I did not take notes of that conversation, but several senators made it known that they were unhappy with the lack of clarity regarding the budget (including how CARES funds have been used) and the lack of communication regarding faculty access to offices and classrooms—with or without students. Today, Monday, 11/2, there is a meeting of the campus' Resources Allocation Advisory Committee (RAAC). It is hoped that after that meeting, there will be greater clarity about how the faculty portion of the CARES Act funding has or will be used.
