## **Installment Payment Plan (IPP) - 3 Payments**

Installment Payment Plan enrollment fee is \$33.00\*. The first installment is due prior to registration, the second installment is due 30 days from the issued agreement date and the 3<sup>rd</sup> installment is due 60 days from the issued agreement date. Available through December 2, 2019.

## Management Payment Plan (MPP) - 4 Payments

The Management Payment Plan enrollment fee is \$35.00\*\*. The first payment for spring 2020 term is due November 1<sup>st</sup> 2019. *If your enrollment appointment is earlier than November 1st, then the first payment is required to register for classes.* The last day to use this plan for spring 2020 is December 2<sup>nd</sup> 2019, however both the November and December payments must be made to enroll at that time.
