The MPP enrollment fee is \$35.00\*\*. **The due dates for this plan are November 1, 2022; December 1, 2022; January 1, 2023 and February 1, 2023.** *If your enrollment appointment is before November 1st, you must complete the first installment on or before* your *appointment date in order to register for classes on that date.* **The last day to sign up for this plan is December 1st, 2022**; however, both the November and December payments must be made to enroll at that time.

The MPP payment breakdown below does not include Non-Resident Fee or Graduate Business Professional Program Fees. The option to add Non-Resident Fees and/or Graduate Business Professional Program Fees to your plan is available during the enrollment process.
