Installment Payment Plan (IPP) - 3 Payments

The IPP enrollment fee is \$33.00* and must be paid with the first installment at the time of enrollment into the plan. The second installment is due 30 days after the first payment and the third installment is due 60 days after the first payment. **The last day to sign up for this plan is December 12, 2024.**

The MPP enrollment fee is \$35.00**. The installment due dates for this plan are November 1, 2024; December 1, 2024; January 1, 2025; and February 1, 2025. The last day to sign up for this plan is December 12, 2024; however, both the November and December payments must be made to enroll at that time.
