... this is NOT a drill!

Recently, Cal State L.A. was put to the test when information from local law enforcement made it necessary for President James M. Rosser and the Department of Public Safety to

Students, faculty and staff evacuated their buildings in an orderly manner, the way they train each quarter. There was, however, one overarching lesson to be learned from the evacuation; to treat each drill as a real emergency situation.

With that in mind, University Police shared a handful of tips to prepare for an evacuation, or BEFORE the next drill.

- Evacuate the building! Practice each drill like there is a real emergency.
- Grab your personal belongings. You will not be allowed to return to the building to get your keys or purse, if it is a real evacuation.
- Have a backpack emergency kit in your car and office. If parking garages are blocked or damaged in an earthquake, your office kit may be your only support to help you aet home.
- Know where your building's evacuation meeting location is, go there only and await instructions.
- Have a transportation backup plan. Someone may have to pick you up, if the Metro system is down, or parking structures are damaged.



A champion for student success: Covino named president of Cal State L.A.



Bringing to Cal State L.A. his long-standing commitment to diversity and student success in higher education, William A. **Covino**, provost and vice president for academic affairs of Fresno State University, has been named by the CSU Board of Trustees as the next president of Cal State L.A. He will be the seventh president in the University's 65-year history.

In making the announcement, CSU Trustee Lou Monville, chair of the presidential search committee, said, "Dr. Covino's leadership at the CSU and his knowledge and experience in public higher

education make him a tremendous asset to Cal State L.A. and the community."

Covino has served as provost and vice president for academic affairs at Fresno State since 2009. In addition to his leadership of the university's eight schools and colleges and oversight of academic goals and educational policy, Covino provided ongoing leadership for the Campaign for Fresno State, the university's fundraising effort that has raised in excess of \$214 million.

Prior to his position at Fresno State, Covino held the position of provost and vice president for academic affairs at CSU Stanislaus from 2006-2009. He returned to the CSU following eight years at Florida Atlantic University, where he chaired the Department of English and was Dean of the College of Arts and Letters. He also has held faculty positions at the University of Illinois at Chicago and San Diego State University.

A Los Angeles native, Covino earned his B.A. in English from UCLA. He holds M.A. degrees in English from CSU Northridge and USC, and earned a Ph.D. in English from USC in 1981.

His scholarly background includes the history and theory of rhetoric, persuasion, imagination, and literacy. He has also authored five books and 37 refereed articles and chapters.

Covino's appointment is effective Sept. 1, 2013. He succeeds James M. Rosser, who has served as president of Cal State L.A. since 1979.

"I am honored to join a university as outstanding as Cal State L.A. and look forward to engaging with students, faculty, alumni and the community to build on its strengths and create opportunities for the future," said Covino.

"The university is uniquely positioned in a global center for the arts, technology and the economy and it boasts a student population as diverse as the city it serves. Cal State L.A. truly reflects the changing face of California in

This coming year we will continue to build the infrastructure for our community engagement effort, from identifying space and resources for the Center for Community Engagement, to strengthening community partnerships, and enhancing community-based learning.

A salute to President Rosser


