### **Prop 30 passes**

With the passage of Proposition 30 by a 54 percent majority, the CSU will avoid a \$250 million "trigger" mid-year budget cut, and will roll back the 9 percent tuition fee increase already in effect for fall 2012.

Annual tuition fees for Cal State L.A.'s fulltime undergraduate students will revert back to \$5,472—the same rate as in the 2011-12 academic year. They will either be refunded or receive a reconfigured financial aid package to account for the revised tuition fee rates.

The CSU Chancellor's Office had asked all campuses to place a hold on fall 2013 applications, pending the measure's outcome. Reduced funding would have negatively impacted enrollment targets, but now Cal State L.A. has been notified to proceed with reviewing applications for fall 2013 new student admissions.

"We are hopeful that the passage of Proposition 30 will be the beginning of the state's reinvestment in higher education," said CSU Chancellor Charles B. Reed. "The state needs to start making up for the devastating budget cuts of the past several years, and focus on higher education as a driver of California's economic future."

## Learning services streamline student success

To support student success, and help them graduate in a more efficient and timely manner, Cal State L.A. offers a variety of student learning services. Many of these comprehensive programs are found within the University Academic Advisement Center, the Writing Center, the Tutorial Center, the Testing Center, and the Students Learning in Communities Program (SLCP), which includes its Peer Mentoring Program.

According to **Steven Jones**, acting dean of Undergraduate Studies, who supervises student learning services on campus, Cal State L.A. has made a "substantial commitment" to helping students achieve academic success and fulfill their ambitions to obtain a baccalaureate degree by enhancing its learning services.

"We have expanded and upgraded the space for the

Writing Center, improved the Advisement Center, and increased the number of tutors and staff advisers available for students," said Jones. "We are also working to expand the availability of learning communities, peer mentoring, and other highimpact practices that have been shown to promote student success. This broad and full-scale effort has resulted in better retention and graduation rates."

Besides helping students with their composition, the **Writing Center** equips them with tips and techniques to pass the Writing Proficiency Exam needed to graduate.

The **Tutorial Center** prepares students to develop the academic skills necessary to understand specific course subject matter and to become independent learners.

The **Testing Center** administers a variety of exams, including the English Placement Test and Entry Level Math exam required for entering lowerdivision students.

The **SLCP** coordinates multiple learning communities with related courses and builds cohorts of students who work together to meet the student learning outcomes for courses within their graduation requirements. Its mentoring program pairs first-time freshmen and entering transfer students with peer mentors who are continuing students.

In particular, his unwavering commitment to access and achievement of students of color and focus on helping them to realize their dream of a college degree is a hallmark of his tenure," said CSU Chancellor Charles B. Reed.

# Student Success The campus continues to make gains in the

persistence and graduation rates of students. The four-year upper division transfer student graduation rate of students who started in fall 2008 was 58.6 percent, over 11 percent higher than the 47.3 percent rate for those who started in fall 2005. This achievement is especially impressive considering that CSULA has now surpassed the 57 percent target set by the CSU Office of the Chancellor for the University, and has done so three years early. In addition, our six-year graduation rate for the freshman cohort beginning in 2006 has increased to 38 percent, up from 34 percent for the 2003 cohort. Finally, based on the recent increases we see in freshman persistence, we are on track to exceed the 45 percent freshman graduation rate target set for CSULA by the Office of the Chancellor by 2015.

With additional support from the Student Success Fee, we hope to continue closing the achievement gap by using the funds for staff advisers in the Colleges and the Advisement Center and through student engagement activities, student research stipends, and with enhanced mentoring, tutoring, and writing support.

#### **Community Engagement**

In partnership with Student Affairs and EPIC, we are working to enhance curricular and co-curricular community engagement activities, while promoting greater communication across campus. This effort will position the campus to achieve the Carnegie Classification for Community Engagement. Funding to support faculty participation in these efforts is available through Engaged Department grants and the Center for Effective Teaching and Learning's Faculty Development Grants Program

#### Collaborative Culture

During Fall Faculty Day, we participated in an engaging presentation led by faculty members from the Charter College of Education. The presentation focused on developing a campus climate that leads to a "psychology of success" through improved personal responsibility, growth, and collaboration. We hope to facilitate more of these discussions as we deepen our culture of working together for a common purpose.

## Distinguished for faculty excellence

Esteemed scholar and environmental biologist **Carlos Robles** is the recipient of this year's Cal State L.A. President's Distinguished Professor Award.

Robles has published numerous articles on the dynamics of predation in seashore communities of California and British Columbia. His innovative work has been featured in textbooks and at the California Science Center.

For 11 years, Robles served as director of the Center for Environmental Analysis at CSULA, funded by the National Science Foundation. Having received over \$17 million in research and research training grants, Robles' efforts support

innovative training in environmental research, including classroom exercises, special field experiences at remote field stations, and internships with government agencies concerned with the environment. He is currently on the Executive Committee of the Cooperative Institute on Marine Ecosystems and Climate (CIMEC), a new research institute established by the National Oceanic and Atmospheric Administration to study the impacts of global climate change.
