**TOTAL FEE PAYMENT** \$ \_\_\_\_\_

Students are **required** to pay tuition and fees before registering for classes unless awarded sufficient financial aid grants, loans, or scholarships; sponsored by a third party; or participating in a payment plan to cover full tuition and fees. Partial or non-payment of tuition and fees by the billing deadline date may result in a hold placed on the student's account, possible disenrollment from the current term, and forfeiture of tuition and fees payments already made. Students may also become ineligible to participate in a payment plan for two consecutive terms.

Cash and check payments can be made in person at One-Stop Financial Services, Student Services Building, Room 2380. Check payments must be made payable to Cal State LA. Please write your CIN on your check payment. Your full payment will allow you to register on the same day, if it is your scheduled appointment date on GET. Checks deposited in the One-Stop Financial Services depository drop box or mailed may take three business days to process before you can register for classes.
