I demonstrated how the lessons on the Bill of Rights and the Constitution convey effectively the history and politics of these documents at an American Bar Association Meeting in Chicago, at an Institute for mentor teachers from 14 western states held at Willamette University, at meetings of the National Council of the Social Studies in New York and Chicago, at the California State University System-wide Civic Education Enhancement Project Conference and at several annual meetings of the California Council for the Social Studies throughout California. I was the principal author for all of these lesson books that have been used by more than one thousand teachers in California and throughout the nation.

### **Personal Commentary:**

During my years at CSULA I was privileged to be part of several “firsts.” In 1970, I was our first campus representative to the Inter-University Consortium for Political and Social Research. At the same time I created and became Director of the Campus Social and Behavioral Science Data Archive.

In 1983, I became the Campus Faculty Advisor for the newly created Los Angeles Superior Court Judicial Internship Program. I supervised a select group of students each year who spent approximately six hours per week with a judge in both a criminal and a civil Court. The internship gives students confidence that they can be successful In law school.

In Fall quarter 1997, I taught the first prototype integrated course in the innovative Model Teacher Education Program. I was selected to team teach the American Government and Politics Course as a result of my involvement with several Summer NEA Institutes for Secondary School teachers of American Government and the subsequent writing and publication of lesson materials concerning the US Constitution and the Bill of Rights.

In my late '70s I still enjoy playing Senior Softball and golf as well as spending time with grandchildren, doing my own yard work, and being involved in activities at church.
